The Butte Creek Watershed Conservancy wishes to invite all interested individuals, specifically local municipal and county government administrators, directors, Council members and Supervisors, to attend the preliminary presentation on **Tuesday, February 10<sup>th</sup>**, **5:30 PM at the Butte County Search and Rescue Building** of the **Floodplain Management Plan** (FMP) for The Butte Creek Watershed.

The FMP includes all of the main waterway and floodplain of Butte Creek from the origins near Jonesville to the outfall gates near Colusa; the contributing drainages east of Hwy 99 running south of Chico to Hwy. 149, along Hwy. 70, to approximately the area of the Thermalito After bay. Additionally, Little Chico Creek from the Stillson Canyon diversion which diverts flows to Butte Creek; Little Chico Creek as it traverses the City of Chico and its urban areas, out to and following the Angel slough area, thence to it's confluence into the Butte Creek system near the Colusa Hwy. crossing west of Gridley.

The area encompasses two of the four established watersheds in the County, several major incorporated municipalities and a vast swath of prime agricultural land as well as major timber areas and the grassland/oak woodlands of Butte County. The broadness of scope and the diversity of constituents, economic interests, habitats, and contributing factors, requires that cooperation and integration be emphasized across the board to ensure the effectiveness of any management goals, practices and potential projects derived from the FMP process.

Your presence and participation currently, and in the intervening months to come will have a long term effect and provide benefit to all the populous of Butte County, and potentially beyond. The Floodplain Management plan is being developed allowing for integration into the County Integrated Hazard Mitigation Plan that is under development. This allows for the potential of increased funding opportunities for certain emergency services and other programs.

The FMP seeks to be the basis, or initialization of, a process that will allow for better flood condition management of the streams, control structures and diversions, contributing to identified areas that are problematic. By investigating the means to provide retention of flood waters by utilizing existing structures, with modifications, to lessen the threat of loss of property, life and infrastructure.

Butte Creek Watershed Conservancy and the County of Butte Sponsoring Public Meeting, July 21, to Discuss the Proposed Mitigation Measures in the Butte Creek Watershed Floodplain Management Plan

Butte Creek Watershed Conservancy is holding a public meeting in Durham to discuss potential solutions to the flooding issues in the Butte Creek and Little Chico Creek watershed. This information will be used to develop the Potential Mitigation Measures section of the Floodplain Management Plan for the Butte Creek Watershed.

The Butte Creek Watershed Conservancy in Butte County is currently in the process of developing a floodplain management plan for the Butte Creek watershed. The Butte Creek Watershed Floodplain Management Plan will be a detailed planning document that will be used to identify flood-related hazards in the watershed. Discussion of Little Chico Creek will also be included because of the diversion of storm water runoff from Little Chico Creek to Butte Creek. The floodplain management plan will also discuss potential flood mitigation strategies that the residents and local government can implement to protect life and property from flooding hazards, minimize environmental impacts of flood restoration, and alleviate potential flooding issues caused by development within the floodplain in the watershed. The plan is a vital first step in obtaining funds for future flood control and restoration projects. The plan will only provide recommended actions and, thus, will not require any formal environmental review at this stage.

To date there have been four public meetings and several Steering Committee meetings to gather input on the flooding issues in the watershed and items that should be addressed in the plan. The last public meeting was held in Chico this last February and over thirty members of the public attended. Measures to address flooding issues in the watershed have been developed and will be presented for public input at a public meeting being held at the Durham Memorial Center in Durham on Wednesday, July 21 at 6:30 pm. Points of discussion will include known flood hazards and potential hazard mitigation measures to

Recognizing that flooding is impacted by activities related to the six other issues and concerns, the Conservancy identified developing a Floodplain Management Plan as a priority action. Education and public outreach will be an important aspect of developing the Floodplain Management Plan.

The Butte Creek Watershed Floodplain Management Plan, developed through this stakeholder-driven process, will provide guidelines for both private and public landowners and federal, state, and local governments to enhance public health and safety and to restore and sustain environmental resources in the watershed. The final plan will only provide recommended guidelines and, thus, will not require any formal environmental review (e.g., Environmental Impact Report).

### How will the Plan be created?

An ongoing series of town hall meetings will be held throughout the watershed to collect information and ideas from local citizens concerning flood-related problems and potential solutions. The Conservancy and Butte County will use the information from these town hall meetings to identify floodplain hazards and mitigation measures. A Technical Advisory Committee will review these hazards and mitigation measures for appropriateness and feasibility. A professional consultant will integrate this and other information into the final Floodplain Management Plan.

The anticipated schedule to develop the Floodplain Management Plan is:

- Town Hall Meetings April/May 2003 •
- Hazards Evaluation/Development of Mitigation Strategies Summer/Fall 2003 •
- Draft Management Plan/Town Hall Meetings Winter 2003 •
- Final Management Plan/Implementation Winter 2004 .

- To meet with the Butte Creek Watershed Conservancy and members of the **Purpose:** general public to discuss the progress of the Butte Creek Watershed Floodplain Management Plan (Plan), and to receive input from those in attendance regarding the process, research, concerns, and items to consider for the Plan.
- Handouts: The following materials were distributed for the Plan presentation:
  - PowerPoint presentation handouts
- **Discussion:** The following summarizes various discussion items (and provides action items) that took place during the public meeting.

Fran Borcalli opened the meeting by providing a general description of how the Plan is being developed. He also introduced Wood Rodgers participants and indicated that Mike Radaideh would talk on specific items related to the LHMP, etc., later in the presentation.

- General Comments: Is the plan already fixed? The Plan should distinguish properties from being located in flood zones and floodplains and should include discussion of Little Chico Creek.
- Andy Farrar: Where is the Plan headed, i.e., how specific will the plan be to planning development?
- Ray Murdoch: Can the Plan alter inaccurate FEMA floodplain designations? • Will the Plan challenge FEMA's floodplain designations? Especially concerned about the South Campus area of Chico.

- <u>Morris Boegek</u>: The current diversion from Little Chico Creek into Butte Creek is conducted based on decisions made with older data the data has increased and improved since that time; is this diversion still appropriate or necessary?
- <u>Mike Campos</u>: Who is responsible for maintaining the channel capacity of Little Chico Creek? What are the flows going into Little Chico Creek and where are they coming from? Who is responsible for maintaining maximum flows in Little Chico Creek? Will Plan look at Dead Horse Slough?
- Jeff Luma: Will the Plan incorporate future growth projections that would affect stream flows? What is the source of flows for the floodplain now delineated? Tiechert Pond (near Hwy. 99), which has been in place since 1963, could be used more fully as a retention pond (is currently a small retention pond for Little Chico Creek).

# ACTION ITEM: Discuss with Will Johnson from BCWC about limitations for utilizing Tiechert Pond as a detention basin.

- <u>Stan Wangberg</u>: Will the Plan recommend increased flows into Butte Creek? Also, the levee design should be investigated, to determine design integrity and any possible weaknesses.
- Dan Davey: What are the plans to mitigate encroachment from vegetation in Butte Creek? Who is responsible for maintenance? *Stuart Edell, from the County of Butte Department of Public Works, responded that DWR, Area 5 is responsible for creek maintenance at Butte Creek.*
- Mike Campos and Others: Will the Plan determine the total volume of water needed to reduced the flow in Little Chico Creek and thereby enable residents near Little Chico Creek to get out of the floodplain and offer mitigation by Dead Horse Slough, Stilson Canyon, etc.? It is possible to set up diversions to minimize flows in Little Chico Creek – divert water back to Big Chico Creek? Can detention ponds be located within the city Limits? Can this information be gathered from a General Plan? Helltown is a problem area – vegetation needs to be cleared. How will debris accumulation and bridges being destroyed be handled? Normal drainage is being affected by imported water. The 1996-1997 event widened the Creek.

# ACTION ITEM: Determine feasibility of minimizing Little Chico Creek flow by diverting flow.

- <u>Greg Blake</u>: Is there a map to look at for potential failures? Is there a way to get FEMA maps at 81/2-11 size?
- <u>General Comment</u>: Need to set up regulatory retention in the City of Chico to reduce flows in Little Chico Creek.

- <u>General Comment</u>: Need to look at Storm Water Master Plan and consider having the City of Chico look into diverting water back into Big Chico Creek.
- <u>General Comment</u>: Due to extensive vegetation overgrowth in creek flow paths, i.e. large trees, historical floods have caused major damage to bridges resulting from debris build up during flows. Brush should be cleared in the flow path of Butte Creek.
- Morris Boegek: What are the additional flows in channels caused by diversion and complex water works?
- <u>Greg Ybanez</u>: Is there a place for the public to look at inundation and levee failure scenarios, such as a map?

# ACTION ITEM: Send Greg Ybanez copy of FIRM panel for County and/or levee failure map.

- Jim Bunnon: Water from the City of Chico's downtown area is being dumped into the Butte Creek watershed. We should look at the Chico City Management Plan and determine water flow locations. Also, the modeling conducted for the City Plan only uses a 24-hour event, whereas it would be more realistic to use a longer time frame, such as a 72-hour event.
- <u>Chuck Kutz</u>: The 2-3 day events are the problems not the 1-day events. Need to deal with gravel deposition in the Durham area especially. The area is being flooded for wildlife habitat.
- <u>Morris Boegek</u>: Desilting and clearing small aggregates in the channel beds, which used to be conducted regularly, has ceased and should begin again. This is especially true since the 1997 event.
- <u>Rob Burtman</u>: Will the Plan address the City of Chico's responsibility to review and update data, analysis, and assessments written in its Management/General Plan, which could affect the Butte Creek Floodplain Management Plan? What would it cost the city to divert water from 5<sup>th</sup> Street to Little Chico Creek and from 9<sup>th</sup> Street to Big Chico Creek?
- <u>General Comment</u>: Will the Plan attempt to address splitting of diversions into Big and Little Chico Creek?
- <u>Ray Murdoch</u>: Will the City Master Plan be reviewed? Will any errors determined be incorporated into the Plan? These public meetings should have representatives from the City and County, Planners, and the Department of Fish and Game present.
- <u>Stuart Edell</u>: Big Chico Creek gates cannot be closed without prior mitigation because it is considered a flood control facility. All flood areas seem to be

central cells. Need to address cells from north, east, and south of Chico. Need a centralized gage.

- <u>General Comment</u>: The Plan should recommend a centralized information center that provides monitoring and research data for all water bodies in the County.
- <u>Mike Campos</u>: The Plan should address detention pond withholding standards for extended storm periods and retention time for storm drainage.
- <u>Mike Campos and General Discussion</u>: Will the Plan challenge and/or validate FEMA's hydrology; review FIS and methodology used?

- **Purpose:** To participate with the Butte Creek Watershed Conservancy in meeting with members of the general public to discuss flood hazard areas and potential mitigation measures to include in the Butte Creek Watershed Floodplain Management Plan (Plan), and to receive input from those attending the meeting regarding areas of concern and potential mitigation measures to consider for the Plan.

- **Discussion:** The following summarizes various discussion items (and provides action items) that took place during the public meeting.

Will Johnson, of the Butte Creek Watershed Conservancy, opened the public meeting and provided a general background on the work as an element of the Conservancy's Butte Creek Watershed Strategic Plan.

Fran Borcalli opened the discussion by providing a general description of how the Plan is being developed, confirming the goals and purpose of the Plan. Angela Carmi presented information related to the value of property within the hazard areas and claims filed for flood damage in relation to flood insurance premiums. Mike Radaideh described the six flood hazard areas being evaluated and potential mitigation measures.

Types of nonstructural mitigation measures were discussed, however the meeting focused on structural measures to mitigate hazards from Little Chico Creek, the diversion channel, and Butte Creek. The following are the comments and questions addressed to the presenters during the meeting.

<u>John Merz</u>: The repetitive loss discussion in the Plan should qualify the comparison between average annual claims paid (that were calculated between the years 1973-2003) and 2003 premiums paid.

<u>Public</u>: What are the environmental impacts to Little Chico Creek as a result of increasing diversions to Butte Creek? What are the challenges associated with this project and how will they be addressed?

<u>Public</u>: What erosion protection measures will be implemented as part of the levee improvements in Butte Creek?

<u>Roger Cole</u>: Have setback levees been considered as an alternative to raising existing levees?

<u>Rick Ponciano</u>: One option is to allow floodwater on the Rancho Esquon property; however, a cost analysis versus raising the levee must be investigated.

<u>Roger Cole</u>: With reduced flow downstream of the Little Chico Creek diversion structure in the Little Chico Creek channel, would there be environmental damage to the channel if maximum flows were reduced to 100 cfs as proposed?

<u>John Merz</u>: Draft and final deadline schedule – review process concerns. Want to be sure that the public reviews the document.

<u>John Merz</u>: Strongly suggests considering setback levees at the Midway crossing as the railroad and Midway Road crossings act as big dams for debris. Will any consideration be given to replacing or enlarging bridges at this location?

<u>Public</u>: Who is making decisions about what vegetation is cleared? Will Johnson responded that the item is under discussion and open to input. This must be a collaborative process between the City, County, and private landowners. A new entity would have to be created for an implementation and maintenance program.

<u>Public</u>: Too many trees and vegetation were taken out of Little Chico Creek last time, which caused extensive erosion. Maintenance frequency is an issue.

<u>Fraser Sime</u>: A maintenance plan is very problematic due to long-term planning and funding, and needs community support. The plan would need to be funded by local funds and work conducted with local staff.

<u>Public</u>: There are historical sediment loading concerns in the area between Durham-Dayton Highway and Rancho Esquon.

<u>Public</u>: The maintenance plan needs to address sediment loading and address specific areas in the watershed.

<u>Karen Hull</u>: There are environmental and fishery concerns with channel clearing. In addition, permits are difficult to obtain.

<u>Michele Ng</u>: Maintenance Area No. 5 addresses levee maintenance, not channel maintenance. Maintenance issues also include the USACE permits required. USACE needs the maintenance baseline to permit DWR to do maintenance but the maintenance baseline needs a mitigation strategy. It is a requirement of the California Department of Water Resources and the California Department of Fish and Game that certain brush and vegetation, such as trees that are at least 4 inches in diameter at chest height, cannot be removed without special permission. To do the maintenance regularly, DWR is understaffed and to do channel maintenance with mechanized equipment requires a Section 404 Permit issued by the USACE, however, USACE cannot issue a Section 404 Permit without baseline maintenance needs specified. Although hand crews are cheaper than using mechanized crews they are much slower, and staff is usually unavailable due to other concerns, such as fire fighting support. The last three years, DWR has had crews doing maintenance work on Little Chico Creek.

<u>Public</u>: How will the maintenance plan be engineered so the work needed is minimal but addresses flooding, sedimentation, and environmental concerns?

<u>Robert Cheal</u>: Bridges destroyed from debris during an event are an issue. This includes crossings at and downstream of Chimney Rock. In addition, the railroad bridge at Midway has been affected by debris damaging the piers. Replacing with open spans should be investigated as an improvement alternative, not just to affect FEMA mapping.

<u>Roger Cole</u>: Bridges need to be designed so large debris can pass unhindered. Removing debris is not always effective and is not reliable as a means of protecting bridges from impacting debris, particularly in large watersheds. Investigate diverting material/debris at bridge piers using catchment/diversion structures upstream of crossings.

<u>Robert Cheal</u>: The plan should provide an approvable bridge design for landowners.

<u>John Merz</u>: The Spanish Gardens septic field and the stream near Parrott-Phelan Dam should be addressed in the plan. In addition, woody debris is an important environmental component of a stream's ecosystem and should be addressed in the maintenance plan.

<u>John Merz</u>: How would information in the Little Chico Creek Existing Conditions report be linked to the plan? The data included in that report should be used in conjunction with evaluating the environmental and fisheries component of the mitigation strategies. It is important that all mitigation strategies that have been analyzed be included in the plan, even if they are not feasible at this time. The plan should also discuss the future negative or positive implications or trends with the proposed mitigation measures.

<u>Gary Cole</u>: Liability is an issue with a maintenance plan and should be determined. It appears that DWR will have to renegotiate current contracts.

<u>Jean Hubbell</u>: There are portions of the Little Chico Creek channel for which DWR is responsible and other portions for which the City of Chico is responsible. At this time, landowners pay the County for channel maintenance for the portion of Little Chico Creek on the west side of Chico. There is also the social aspect of the channel maintenance that needs to be addressed. For example, the homeless inhabitants utilizing the channel vegetation for shelter, and the potential danger associated with alleged illegal activity occurring in some of the residences adjacent to the channel.

<u>Karen Hull</u>: For areas where DWR is responsible, liability will be an issue in the maintenance plan. The USACE gave authority to the Reclamation Board to maintain the levees once built. The Reclamation Board then gave authority to DWR to maintain the levees. Any modification to the current maintenance plan, reconstruction (raising) of levees and schedule requires approval by the Reclamation Board, and triggers renegotiation and raises liability issues. In addition, restrictive environmental constraints have to be accounted for in a maintenance plan, such as the elderberry bush and the associated species of beetle.

<u>Michele Ng</u>: DWR is currently investigating the potential for "Safe Harbors" agreements to implement regarding elderberry issues, but there may be conflicting issues.

Action Item: Wood Rodgers will check on the Habitat Conservation Plans (HCP) for Butte County and incorporate discussion of potential environmental impacts resulting from alternative mitigation measures

Introductions were made around the table and the meeting was recorded by tape.

		Fran Borcalli opened the discussion by describing the process of the development of the goals and objectives of the Plan and emphasized that the timing of this meeting regarding the public comments was driven by the contractual schedule. He stated that the goal and objectives were derived

from the Butte Creek Watershed Management Strategy and agreed upon by the Butte Creek Watershed Conservancy.

### Note: An additional goal was added by the County to develop the Plan so as to comply with the Disaster Mitigation Act of 2000 (DMA 2000), Local Hazard Mitigation Plan.

The goal and objectives were presented at several public meetings and input or suggestions were solicited, but none were received. These include:

Goal: Minimize environmental impacts of required flood management.

- *Objective 1: Utilize relevant information to develop flood protection measures that protects life and property and enhance fish and wildlife habitat.*
- Objective 2: Support improved performance and coordination among and within agencies responsible for providing flood protection, post-flood restoration, and protection of habitat.
- *Objective 3:* Support the development of pre-flood emergency response management.
- *Objective 4:* Establish criteria for development within the floodplain, which will not adversely impact the floodplain, flood flow capacity, or neighboring properties.
- *Objective 5: Develop the document to comply with the Disaster Mitigation Act of 2000, Local Hazard Mitigation Plan.*

Fran Borcalli emphasized that the goal and objectives were used to guide the development of the Plan. Fran discussed the interpretation of the goal as determined by the Steering Committee and consulting staff, as a focus on flood control, with environmental impacts determined at the time of a mitigation proposal. The purpose of the Plan, based on input received from the public and the scope of work, was to address the flooding hazard based on the regulatory floodplain. If there were required measures to implement for flood control or flood management, than every opportunity would be used to enhance the environmental aspects of that area.

Roger Cole explained that the condition of the stream in the lower reaches of Butte Creek documented in the geomorphology report does not provide enough gravel for the fall run to spawn. If there is a better habitat in Butte Creek in the lower reaches of the system, the fall run would not have to spawn so far upstream and prevent the crowding of the spring and fall run. The geomorphology report cites specific reach-by-reach areas that are devoid of necessary gravel for spawning.

Rich Smith discussed that there is a significant fall run in the upper reaches of Butte Creek that varies from year to year. Fall run fish are kept from spawning above Okie Dam due to DFG obstruction.

Roger Cole emphasized that the environmental impacts, any necessary studies, or required permits should be identified when the mitigation measures are proposed as this would be the most cost-effective process for implementing mitigation measures.

Wood Rodgers concluded that a discussion of the interpretation of the goal and objectives, a distinction between a regulatory and actual floodplain, and a discussion of potential environmental impacts of the mitigation measures would be included in the Plan.

3. Public Outreach Process

Wood Rodgers discussed the public outreach process and provided the following listing of key outreach activities:

- Mailed announcements to over 1,600 residents, businesses, organizations, educational institutions, conservancies, federal and state agencies, and other local entities informing them of the development of the Butte Creek Watershed FMP and inviting them to public meetings. A database was created that contains the contact information for the entities that received the mailings.
- Public meetings:
  - April 24, 2003, 6:00-9:00 p.m. at Lt. Larry Estes Search and Rescue Building in Chico
  - April 28, 2003, 6:00-9:00 p.m. at Colusa Industrial Properties
  - May 7, 2003, 6:00-9:00 p.m. at Durham Recreation and Park District Memorial Hall
  - o February 10, 2004, 5:30-8:00 p.m. at the Chico Association of Realtors
  - o July 21, 2004, 6:00 7:30 p.m. at the Durham Memorial Building
  - o January 25, 2005, 9:00-12:00 at the Butte County BOS Chambers Hall
- Media channels (KRCR TV-Channel 7, KHSL TV Channel 12, KNVN Channel 24, KCVU TV/UPN Channel 21, the Water and Resource Conservation District Web site, in the Colusa Sun Herald, Willows Journal, Orland Press Register, and the Appeal Democrat. A link was created on the BCWC Web site).

An inquiry was made to determine whether the effort was deemed adequate and all meeting participants concurred that the public outreach efforts were more than sufficient.

4. Refine Scope of Work from Public Input

Fran Borcalli stated that on June 23, 2003 a meeting, that included members of the Butte Creek Watershed Conservancy, Butte County, and Wood Rodgers, was held to confirm a revised scope of work for the Plan. The revised scope of work was based upon the outcome of the public meetings that occurred prior to June 23, 2003.

The revised scope of work was agreed upon by members at the June 23, 2003 meeting and was used to determine of course of the development of the Plan.

5. Discussion of Proposed Mitigation Measures

Fran Borcalli discussed the proposed mitigation measures in the Plan and agreed that the Plan should emphasize the land use issues, such as development behind levees, and incorporate these concepts into the Butte County General Plan as an important mitigation measure. Roger Cole added that the language in the Plan that discusses reducing the flow in Little Chico Creek at the diversion to 100 cfs should include the fact that environmentally this is not be feasible. Mike Radaideh mentioned that the purpose of the 100 cfs is to demonstrate how low the flow rate should be downstream of the diversion structure to accommodate inflow from Dead Horse Slough and local drainage while staying within the maximum capacity of the Little Chico Creek channel.

Roger Cole cited excerpts from the Geomorphology Report written by Williams, Kondolf, and Ginney to emphasize the issues associated with sedimentation, sediment transport, and the lack of riparian habitat in reaches of Butte Creek. Roger stated that according to the Geomorphology report, the lower portions of Butte Creek do not have enough gravel for the fall run and fish would have to travel further upstream to spawn. Fran Borcalli pointed out that the reaches of Butte Creek in the lower watershed are too deep for spawning conditions, even with additional gravel added.

Rick Ponciano, of the Butte Creek Watershed Conservancy, stated that spawning areas are being closely observed downstream of Rancho Esquon. Rich Smith, of the Butte Creek Watershed Conservancy, stated most gravel beds have always been above the Midway Bridge where the water temperatures are cooler and spawning conditions are better in general.

Roger Cole mentioned that he had drafted the fisheries section of the Butte Creek Watershed Existing Conditions Report and that in 1995, the spring run was at a population of approximately 500 and recent counts have shown populations to be over 20 times that amount.

Roger Cole emphasized the need for an evaluation of setback levees and handed out a schematic of a hydrologic system in a river, which illustrated the hydraulic floodplain.

Fran Borcalli emphasized that there was not any evidence that would drive the analysis to look at setting the levees back. From a fisheries standpoint, the restoration for the fall and spring chinook salmon has been successful and so mitigation in the Butte Creek system to enhance fisheries did not make sense, when staying out of the Butte Creek system ensures that nothing is done to affect the successful salmon restoration. Also, Fran Borcalli stated that downstream of Midway Road, due to the rural aspect of the area, there is limited exposure to flood damage, and from a practical standpoint, moving levees back for fisheries or flood control would be costly. From a vegetation standpoint, it would be a consideration.

Rick Ponciano explained that allowing water on the rice fields might not be an option due to the fact that these fields are filled with decomposition water and are used by duck clubs.

Fran Borcalli also pointed out that setting back levees should be considered on a system-wide level and due to the repetitive loss damage and FEMA claims, would prove expensive and less likely to be funded than elevating portions of the existing levees and certifying the levees.

Fran Borcalli explained that the floodplain in the FEMA FIRMs is not a real floodplain, as we understand it, because the existing levees have not failed or overtopped; it is a regulatory floodplain. The least expensive mitigation for the regulatory floodplain is to restore the existing levees, because the cost would be nominal when compared to building a new levee. In evaluating flood hazard mitigation, several measures were considered, such as diverting water through Hamlin Slough, storage, diverting water out of Butte Creek to obtain the required freeboard, and setback levees. Due to the affect on juvenile salmon, the environmental impacts of tearing out existing levees, the necessity of providing setback levees for entire reach of Butte Creek if one reach has setback levees and the cost associated with this, and the potential loss of bedload, such as at Parrott-Phelan Diversion Dam proved those mitigation measures to be ineffective. Mitigation was to address Butte Creek as a comprehensive system.

Mike Radaideh discussed the added bridge design/replacement analyses to the Plan in Appendix H and the availability of the analyses on the Butte Creek Watershed Conservancy Website about 10 days before the end of the comments period. The bridge design analysis includes conceptual design drawings and discussion for a few of the key bridges of concern within the watershed and possible measures to protect the piers from debris loading. The Nelson Bridge, the Railroad Bridge, and the Durham-Dayton Bridge were analyzed.

Action Item: Wood Rodgers will send a CD with the bridge design analyses to Will Johnson, Roger Cole, and Robin McCollum.

Stuart Edell, of Butte County, requested including all of the mitigation alternatives analyzed prior to the draft Plan.

Roger Cole pointed out that sediment transport as an issue to decreasing capacity should be addressed, and mitigation should emphasize enhancing fish and wildlife. Stuart Edell explained that Cherokee Canal, Sycamore Creek, and Mud Creek have sedimentation issues; however, necessary permits or projects from the U.S. Fish and Wildlife and the U.S. Army Corps of Engineers have been difficult to obtain.


Robin McCollum pointed out that a County standard is needed to ensure that when riprap is needed for channel bank protection, it does not reduce the capacity of the channel, and issues associated with channel grade should be examined, as this contributes to scouring and increased velocities. Stuart Edell said that the County should already have in place a standard plan on how to handle riprap so as not to reduce channel capacity.


Fran Borcalli and Stuart Edell pointed out that due to the topography adjacent to the levees sloping away from the channel in the upper reaches of Butte Creek, if water were allowed to flow out of bank, a large portion of the water would not flow back into the channel or form additional channels, but would leave the channel.

6. Next Steps

The final Plan will be checked by Will Johnson to ensure that comments have been addressed adequately and he will present to the Butte Creek Watershed Conservancy Board for adoption in May 2005. Following the Butte Creek Watershed Conservancy Board adoption, the final Plan will be submitted by the Butte County staff to the Butte County Board of Supervisors for adoption. All public comments will be provided as an appendix in the final Plan, with a letter to address each person who commented.






# Watershed

A Region Bounded by a Divide, such as Mountains or Ridges, and Draining to a Watercourse or Body of Water







